This is in continuation of our letter dated December 23, 2023 conveying the sanction of Rs.1,50,000/- (Rupees: one lakh fifty thousand only) of the ICSSR North-Western Regional Centre, P.U. Chandigarh for organizing a workshop on "Depression and Suicidal Trends Among Young Female Folk of Kashmir" in collaboration with the Regional Centre. The grant was sanctioned for the year 2023-24. We have reconsidered the sanction and has allowed the 'Centre for Women's Studies and Research' University of Kashmir, Srinagar to organize the workshop at its own level on the proposed dates i.e May 21-22, 2024.

We are enclosing the Grant-aid-bill, conditions and undertaking for submission duly signed by the Chairperson of the Centre and Registrar, University of Kashmir to withdraw the 75% as advance on account first installment of the total sanctioned grant of Rs.1,50,000/- (Rupees: one lakh fifty thousand only) and 25% of the remaining grant shall be released (second installment) only after the submission of Utilisation certificate in form GFR 12A (copy attached).

SANCTION ORDER

1. Sanction of the Competent Authority is hereby conveyed in terms of Government of India's Rule 20 of the DFP Rules 1978 read with Section 11(2) of the National Commission for Women Act, 1990 for payment of ₹ 2, 05,000/- (**Rupees Two Lakh Five Thousand only**) to **Center for Women's Studies and Research, University of Kashmir** as financial assistance for organizing a Seminar on "**Socio-Cultural Dimensions of Sexual and Reproductive Health of Women in Kashmir**" on behalf of National Commission for Women.

2. The amount will be released in two instalments: (i) ₹ Rs. 1, 02, 500/- (**Rupees One Lakh Two Thousand Five Hundred only**) as the 1st instalment equivalent to 50% of the sanctioned amount (ii) ₹ 1, 02, 500/- (**Rupees One Lakh Two Thousand Five Hundred only**) i.e., balance 50% of the sanctioned amount as full and final payment on receipt of the satisfactory Seminar Report in the prescribed format along with audited item wise expenditure, original bills/vouchers, income and expenditure account and utilization certificate from Chartered Accountant as per GFR 12-A and cost estimate (item-wise) as under:



3. **The release of the assistance would be subject to the following terms and conditions:**

- i. The Seminar should be organized by 31.12.2023 and all required documents must be submitted to the Commission **mandatorily within one month** from the date of organising the Seminar.
- ii. The satisfactory report as per format of SOP about the Seminar including the following details should reach the Commission **within one month** after organising the Seminar.
- iii. The grantee organization should submit Seminar report and press release, if any, and other documents as indicated in **Para 3 (ii)** above to the National Commission for Women in a prescribed format along with its soft copy.
- iv. It is mandatory to display '**National Commission for Women**' with **DATE** on the background of the Seminar and also at the cover page of the report of the Seminar.
- v. The amount will be spent for the purpose for which it has been sanctioned and no portion thereof will be utilized for any other purpose. No equipment or asset will be purchased out of the assistance.
- vi. The sanctioned amount will not be exceeded under any circumstances and any portion of the assistance remaining unutilized will be refunded to the Commission.
- vii. Original bills and vouchers need to be submitted along with audited item-wise accounts, income & expenditure account, and utilization certificate in GFR 12-A duly certified by Chartered Accountant/Chief Finance Officer for final settlement of accounts.
- viii. An interest @ 12% per annum will be recovered in case the organization does not undertake the sanctioned Seminar within the approved time period.
- ix. An interest @ 12% will be recovered from the due/remaining instalment in case the organization delays submission of documents for more than two months after organizing the Seminar.

4. Accordingly, an amount of ₹ Rs. 1, 02, 500/- (**Rupees One Lakh Two Thousand Five Hundred only**) is being released as 1st instalment of GIA. The expenditure is debit to Assistance to other organization for organising "Webinar/ Seminar/Conference/Workshop" NON-NER and will be met out of the funds of National Commission for Women during the financial year 2023-24.
